The bill contains funding for the Department of Cultural Affairs, Department of Economic Development, Workforce Development and for the Regents Economic Development activities. The bill appropriates \$42.5 million from the general fund, an increase of \$1.2 million more than FY 14.

The bill also appropriates \$33.6 million from other funds, an increase of \$1.65 million from FY 14. Of the \$32.9 million in other funds, the Skilled Worker Job Creation Fund accounts for \$25.6 million.

The bill appropriates \$17.7 million in FY 15, an increase of \$1.025 million over FY 14.

- There is a new \$1 million line item for STEM Apprenticeships. The purpose of the program is to assist in placing Iowa students studying in the fields of science, technology, engineering, and mathematics into internships that lead to permanent positions with Iowa employers. Language for the STEM Apprenticeship program is contained in the Broadband Expansion bill being considered in the House and Senate. The appropriation is contingent upon the broadband legislation becoming law.
- The Councils of Governments (COGS) is increased of \$25,000 over FY 14 for a total of \$200,000.
- The Governor proposed a new line item for Midwest Japanese Conference which Iowa is hosting. The bill does not provide funding.

The bill appropriates an additional \$101,000 from the general fund for Small Business Development Centers. Small Business Development Centers also receive \$735,728 from the Skilled Worker Job Creation Fund for a total of \$836,728.

The bill appropriates \$17 million in FY 15 to Iowa Workforce Development, an increase of \$74,000 from FY14. The increase goes to the offender reentry program to allow them to fill an additional FTE. The Governor proposed three new line items, two separate \$1 million appropriations for Home Base Iowa initiative and \$1.4 million for digital and vocational literacy. These new line items were not funded in the budget.

## Skilled Worker Job Creation Fund

The Skilled Worker Job Creation Fund was created in 2013 and receives \$66 million in gambling revenues that had previously been deposited into the general fund.

This year the Skilled Worker Fund programs are split between the Education Budget and the Economic Development Budget. The Economic Development Budget receives \$25.6 million from the Skilled Worker Job Creation Fund.

The regents institutions and the High Quality Jobs program receive status quo funding from the Skilled Worker job creation fund.

- **Iowa State University** receives status quo funding from the skilled worker job creation fund for FY15, \$2.42 million, which helps fund Small Business Development Centers and the Iowa State University Research Park. The bill requires at least \$735,728 of their appropriation fund small business development centers.
- **University of Northern Iowa** receives status quo funding from the skilled worker job creation fund for FY 15, \$1.06 million. The appropriation for economic development activities at the University of Northern Iowa funds the Institute for Decision Making, the MyEntrenet service and the Metal Casting Institute

- **University of Iowa** receives status quo funding from the skilled worker shortage fund for FY 14, \$2.2 million. The appropriation supports the University of Iowa research park and the advanced drug development program.
- **Regents Innovation Fund** receives status quo funding for FY 15.

The bill increases the Workforce Development Fund from \$4 million to \$5.75 million. The Workforce Development Fund Account receives funding from the New Jobs Credit per the withholding mechanism in Iowa Code chapter 260E. After a business's training obligation has been paid off, an amount equal to 25.0% of the total amount of withholdings paid by a business for jobs created under the Program, are diverted to the Workforce Development Fund Account for a period of 10 years. Initially, the program had no cap on the amount of funds diverted. The General Assembly set a cap of \$10.0 million in 1996, lowered the cap to \$8.0 million in 2000, and set the cap at \$4.0 million in 2001.

Prior to the cap being raised, \$3 million dollars went to worker retraining and \$1 million went to apprenticeship programs. With the increase in the cap, \$2.75 million now goes to apprenticeship training while business retraining funds remain the same at \$3 million.

## Amendments

**H-8183 By Isenhart and Kearns.** Allocates \$1,000 out of the Labor Services appropriation to direct the labor commissioner and the attorney general to investigate the use of noncash or check wage payment in Iowa. The amendment also directs the commissioner to submit his findings to the legislature.

**H-8187 by Deyoe.** Makes a corrective change to the code language dealing with the now increased Workforce Development Fund.

**H-8190 by M. Smith.** The Senate wage theft legislation. Requires businesses to tell workers in writing what they are going to be paid and how they are going to be paid. Employers would also have to give advance notice of wage deductions, instead of after the fact.

**H-8191 by Running-Marquardt.** Adds 1 additional OSHA FTE to the Department of Workforce Development in the Department of Workforce Development.

**H-8193 by Running-Marquardt.** Adds 1 additional FTE for child labor enforcement in the Department of Workforce Development.

**H-8194 by Running-Marquardt.** Adds 1 additional FTE for wage investigation in the Department of Workforce Development.

**H-8195 by M. Smith.** States that any department receiving funds in the Economic Development budget must give first preference to Iowa products and second preference to products made in the United States.
